A Salute to Veterans 5K: Saturday April 16th @ 9:00am. \$20/adult; \$10 ages 12 & up. Pre-registration closes 4/12/16. An extra \$10 will be charged on race day. Short sleeved wicking shirts \$20, must be ordered by 3/26/16.

Lewis Creek Covered Bridges 5K/10K & Half Marathon: 5K 10K Half Marathon Saturday May 7th @ 8:00am. \$25 for 5K/10K; \$45 for Half Marathon. Pre-registration closes 05/03/16. An extra \$10 race day will be charged on race day. Includes finisher medal for ALL racers. Short sleeved wicking shirts, \$20, must be ordered by 4/16/16.

Charlotte Covered Bridge 5K/10K & Half Marathon: 5K 10K Half Marathon Saturday September 10th @ 8:00am. \$25 for 5K/10K; \$45 for Half Marathon. Pre-registration closes 09/06/16. An extra \$10 race day will be charged on race day. Includes finisher medal for ALL racers. Long sleeved wicking shirts are available for \$20, must be ordered by 8/20/16.

Adams Apple Orchard Run/Walk: 2 Mile Walk or Run 5K Run September 25th @ 9:00am. \$20/individual, \$10 ages 12 & under. Pre-registration closes 9/20/15. An extra \$10 will be charged on race day. Includes a small bag to pick your own apples after the race. **THERE ARE NO T-SHIRTS FOR THIS RACE.**

Shelburne Farms 5K: Sunday October 2nd @ 8:00am, \$25/racer. Pre-registration closes 9/27/16. Long-sleeved wicking shirts \$25, must be ordered by 9/11/16. LIMIT OF 175 racers.

Muddy's Buddies 5K Walk/Run: October 16th @ 9:00am @ VT Teddy Bear. \$20/adult, \$10 ages 12 & under, children in strollers and packs free. Pre-registration closes 10/11/16. Waiver & Release Form

Read carefully before signing.

In consideration of the acceptance by sponsor of my entry in this event, I hereby waive any liability the sponsor may have arising out of my participation in this event. Furthermore, I acknowledge, agree and represent that I have read the rules and regulations of the event, and as a participant, I understand the nature of the activity required to participate in this event and the risks and dangers presented by such activity, including, but not limited to, serious bodily injury, permanent disability, paralysis and death, or the loss of personal property ("Risks"), and that I am participating in this event voluntarily and entirely **at my own risk**. Risks, regardless of the nature thereof, may be caused by my own actions or inactions, the actions or inactions of others participating in this event, the condition of the facilities or premises in which the activity takes place, or the negligence or willful misconduct of the Herzog Enterprises, LLC, RaceVermont.com Race Series, Shelburne Health & Fitness LLC, Shelburne Field House Inc, Deer Point Management LLC, Shelburne Recreation Department, Town of Shelburne, Town of Charlotte, Town of Ferrisburgh, City of Burlington, Shelburne Farms, and all sponsors of this race (collectively, the "Released Parties").
