If any term or provision of this Waiver and Release shall be deemed by a Court of competent jurisdiction to be invalid or to be limited by operation of law or otherwise, such term or provision shall be limited accordingly and the remaining terms and provisions shall be given full force and effect, it being my intention that the agreements and covenants made by me in this Waiver and Release shall be interpreted and enforced to the fullest extent permitted by applicable law.
